## **INTERNSHIPS: A Programmatic Review**

### **Role and Scope**

In the University of Georgia Bulletin, an internship is described as “a supervised work experience.” Although that is a good shorthand designation, it cannot capture everything involved for the student in HACE 5910/7910. Within the Department of Housing and Consumer Economics (HACE), the internship is meant to be an integral part of students’ programs. Internships offer students opportunities to:

- *apply subject matter learned from their course work to the work place*
- *develop new skills through work as an intern*
- *gain additional experience which will help students as they establish their own careers*

Thus, an internship is neither simply a job nor just a way to gain experience. The distinguishing marks of an internship are its academic merit and the contribution it makes to the student’s program. The internship experience these students have had underscores the key role internships play in the HACE Department’s overall program. This report explains the internship program and highlights recent developments over the past year.

### **Patterns of Enrollment and Placement**

Data on internship enrollments for the past seven years are provided in the following pages. Two conclusions can be drawn from these pages. First, internships have played an important and on-going role in departmental offerings and second, internships are playing an increasingly important role in students’ programs of study, especially as the number of students in HACE increases. Employers are requesting a track record of work experience of recent graduates.

#### ***Internships by Academic Years 2005-2011***

*Detailed information on student placements during Spring, Summer and Fall semesters 2005-2011 is given in the following pages. The diversity of internship site placement is striking. Internships are clustered in the Athens-Atlanta area, but placements range across the state, nation and the world. It is difficult to characterize the typical internship. Although many are with small companies and family-owned businesses, internships with major corporations are also represented. This information is especially helpful for the student who would like to contact an internship site that is familiar with their program of study. These placements indicate the range of placements and provide future students with ideas for internship possibilities.*
